Expense-related allowances.

A. Pursuant to s 157 of the *Fair Work Act 2009* (Cth), the above award is varied as follows:

1. By deleting the amount "\$17.50" appearing in clause 30.2(c)(ii) and inserting "\$17.90".

2. By deleting the amount "\$33.12" appearing in clause 30.2(d)(ii) and inserting "\$33.88".

3. By deleting the amount "\$0.95" appearing in clause 30.3(a) and inserting "\$0.98".

4. By deleting the amount "\$16.81" appearing in clause 30.3(c)(ii) and inserting "\$17.92".

5. By deleting the amount "16.81" appearing in clause 30.5(f)(ii) and inserting "17.92".

6. By deleting the amount "\$17.52" appearing in clause 54.1(a) and inserting "\$17.92".

7. By deleting the table appearing in clause 54.1(b) and inserting the following:
