Expense-related allowances.

- A. Pursuant to s 157 of the *Fair Work Act 2009* (Cth), the above award is varied as follows:
- 1. By deleting the amounts "\$759.38" and "\$879.28" appearing in clause 17.3(b)(i) and inserting "\$786.31" and "\$910.46" respectively.
- 2. By deleting the amount "\$0.42" appearing in clause 17.3(b)(ii) and inserting "\$0.43".
- 3. By deleting the amount "\$0.95" appearing in clause 17.3(b)(vi) and inserting "\$0.98".
- 4. By deleting the amount "\$16.80" appearing in clause 17.3(c)(i) and inserting "\$17.90".
- 5. By deleting the amount "\$14.66" appearing in clause 17.3(e)(ii) and inserting "\$15.62".
- 6. By deleting the table appearing in clause C.4.1 and inserting the following:
