Expense-related allowances.

- A. Pursuant to s 157 of the *Fair Work Act 2009* (Cth), the above award is varied as follows:
- 1. By deleting the amount "\$0.95" appearing in clause 18.3(b) and inserting "\$0.98".
- 2. By deleting the amount "\$92.92" appearing in clause 18.3(c)(i) and inserting "\$96.22".
- 3. By deleting the amount "\$22.63" appearing in clause 18.3(e) and inserting "\$24.12".
- 4. By deleting the amount "\$16.20" appearing in clause 18.3(f) and inserting "\$17.27".
- 5. By deleting the amount "\$40.67" appearing in clause 18.5(b)(i) and inserting "\$42.14".
- 6. By deleting the amounts "\$140.11" and "\$190.77" appearing in clause 18.5(b)(ii) and inserting "\$145.18" and "\$197.68" respectively.
- 7. By deleting the amount "\$122.34" appearing in clause 18.5(c)(i) and inserting "\$126.77".
- 8. By deleting the amount "\$0.95" appearing in clause 18.5(f) and inserting "\$0.98".

9. By deleting the table appearing in clause B.2.1 and inserting the following:

Outports allowance—Overnight stay—transfer for defined number of days	18.5(b)(ii)	145.18	per day
Outports allowance—Overnight stay—transfer for flexible number of days	18.5(b)(ii)	197.68	per day
Outports allowance—Saturday, Sunday or holiday	18.5(c)(i)	126.77	per day
Outports allowance—Use of own motor vehicle	18.5(f)	0.98	per km

B. This determination comes into operation on 1 July 2024. In accordance with s 165(3) of the *Fair Work Act 2009* (Cth) this determination does not take effect in relation to a particular employee until the start of the employee's first full pay period that starts on or after 1 July 2024.
