Expense-related allowances.

- A. Pursuant to s 157 of the *Fair Work Act 2009* (Cth), the above award is varied as follows:
- 1. By deleting the amount "\$18.23" appearing in clause 19.3(a)(ii) and inserting "\$19.43".
- 2. By deleting the amounts "\$17.50" and "\$33.12" appearing in clause 19.3(b) and inserting "\$17.90" and "\$33.88" respectively.
- 3. By deleting the amounts "\$0.96" and "\$0.32" appearing in clause 19.3(d)(i) and inserting "\$0.99" and "\$0.33" respectively.
- 4. By deleting the table appearing in clause C.2.1 and inserting the following:

Vehicle allowance—use of own vehicle—Motorcycle	19.3(d)(i)	0.33	per km

B. This determination comes into operation on 1 July 2024. In accordance with s 165(3) of the *Fair Work Act 2009* (Cth) this determination does not take effect in relation to a particular employee until the start of the employee's first full pay period that starts on or after 1 July 2024.
