3. By deleting the amount “\$15.58” appearing in clause 17.3(c)(ii) and inserting “\$16.60”.
4. By deleting the amounts “\$15.58” and “\$13.98” appearing in clause 17.3(c)(iii) and inserting “\$16.60” and “\$14.90” respectively.
5. By deleting the amount “\$13.03” appearing in clause 17.4(a)(i) and inserting “\$13.49”.
6. By deleting the amount “\$26.14” appearing in clause 17.4(a)(ii) and inserting “\$27.07”.
7. By deleting the amount “\$0.95” appearing in clause 17.4(b)(v) and inserting “\$0.98”.

8. By deleting the table appearing in clause B.1.1 and inserting the following:

B. This determination comes into operation on 1 July 2024. In accordance with s 165(3) of the *Fair Work Act 2009* (Cth) this determination does not take effect in relation to a particular employee until the start of the employee's first full pay period that starts on or after 1 July 2024.
