Expense-related allowances.

A. Pursuant to s 157 of the *Fair Work Act 2009* (Cth), the above award is varied as follows:

1. By deleting the table appearing in clause 17.3(d)(i) and inserting the following:

- 2. By deleting the amount "\$5125" appearing in clause 17.5 and inserting "\$5311".
- 3. By deleting the amount "\$5125" appearing in clause A.2.1 and inserting "\$5311".

4. By deleting the table appearing in clause B.2.1 and inserting the following:

| Personal effects allowance— vessels granted a temporary licence—an amount not exceeding | A.2.1 | 5311 | per occasion |

B. This determination comes into operation on 1 July 2024. In accordance with s 165(3) of the *Fair Work Act 2009* (Cth) this determination does not take effect in relation to a particular employee until the start of the employee's first full pay period that starts on or after 1 July 2024.
