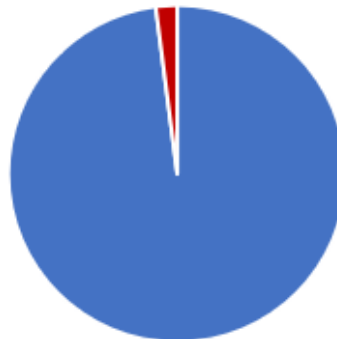

- No - 2 (2.0%)

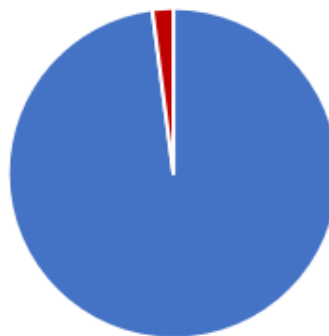

- No - 2 (2.0%)

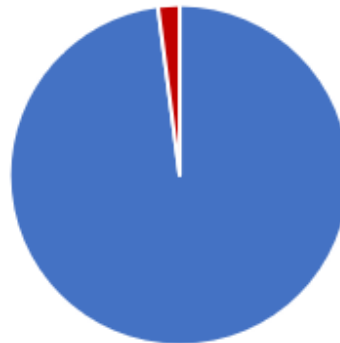

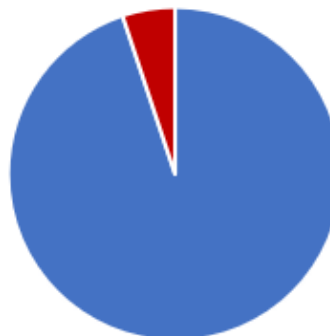

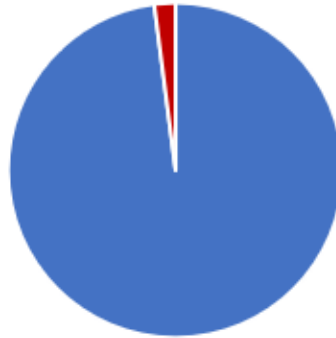

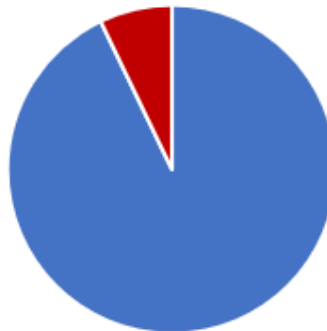

- No - 7 (7.1%)



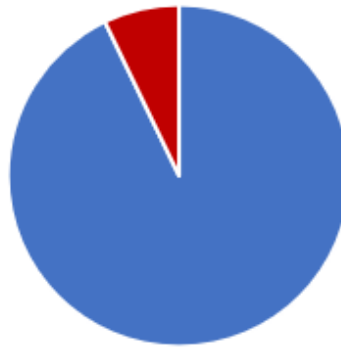

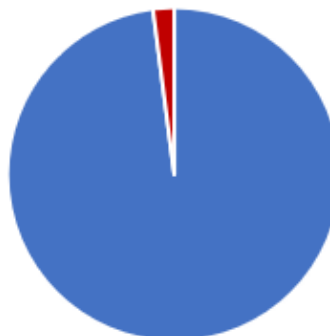

■ No - 2 (2.0%)

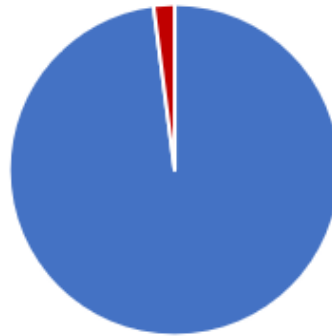

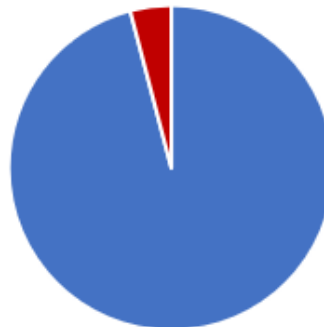

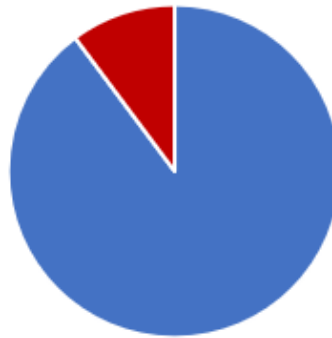

- No - 10 (10.2%)

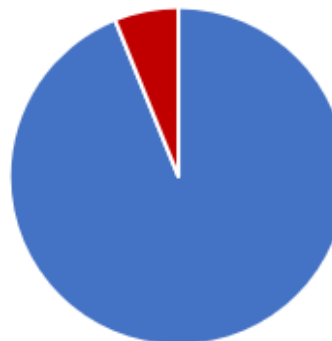

- No - 6 (6.1%)

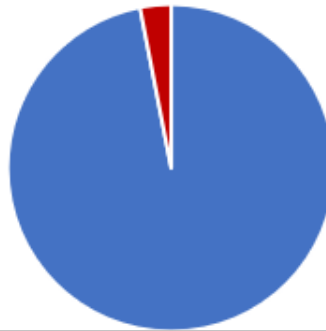

- No - 3 (3.1%)

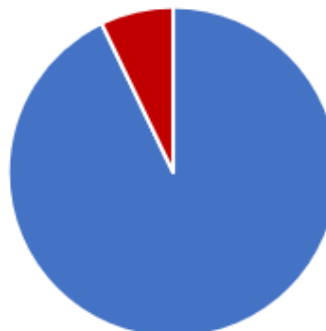

- No - 7 (7.1%)

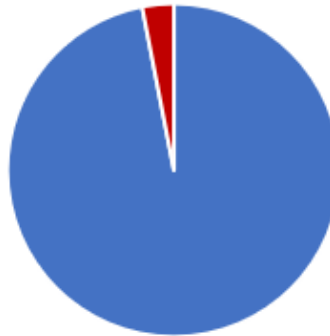

- No - 3 (3.1%)

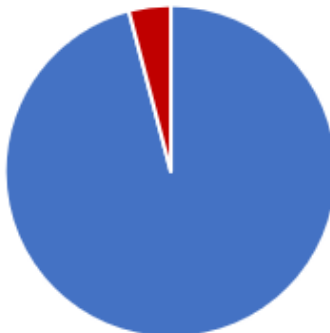
