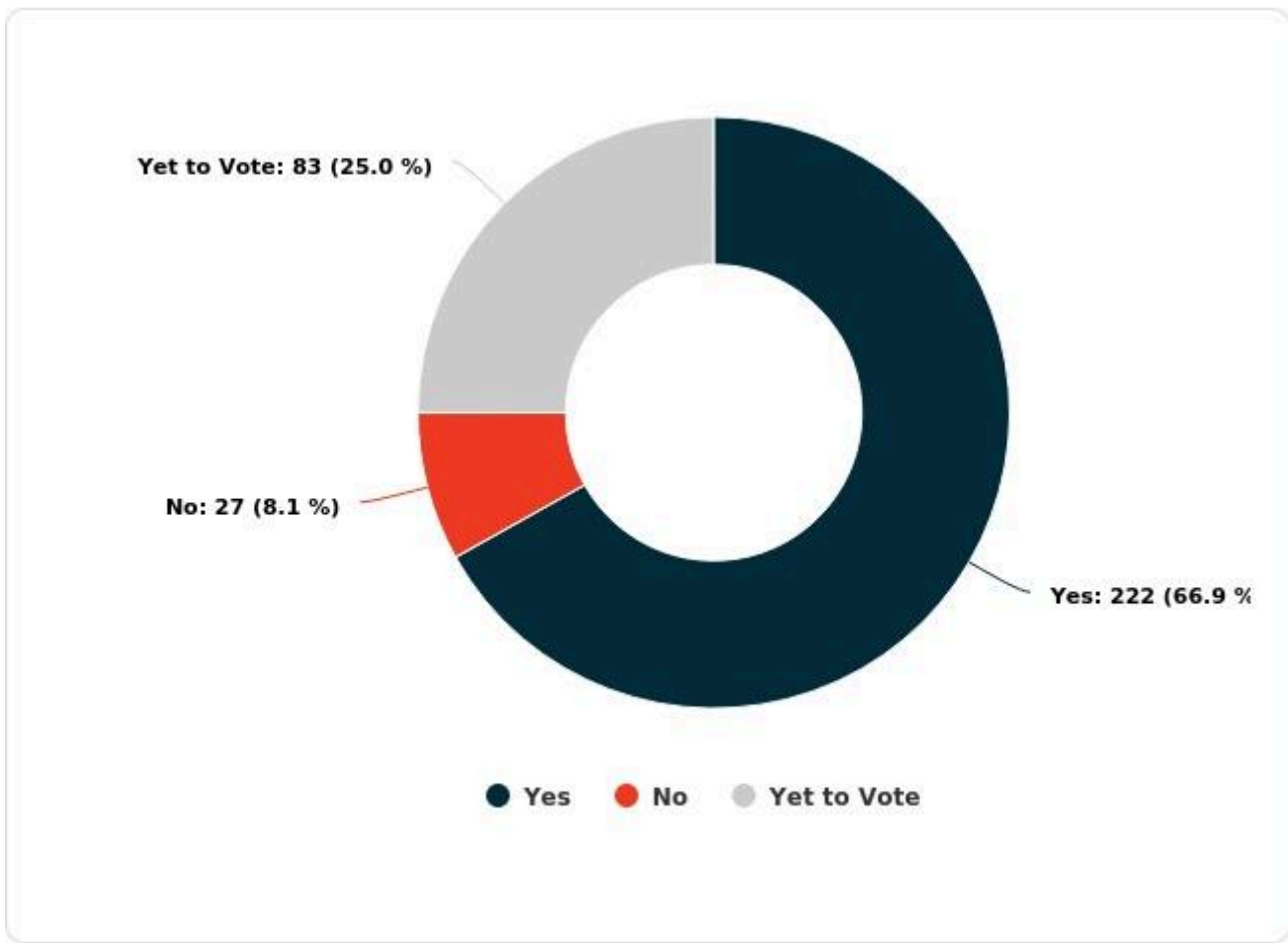
3. An unlimited number of stoppages of work for the duration of 4 hours?



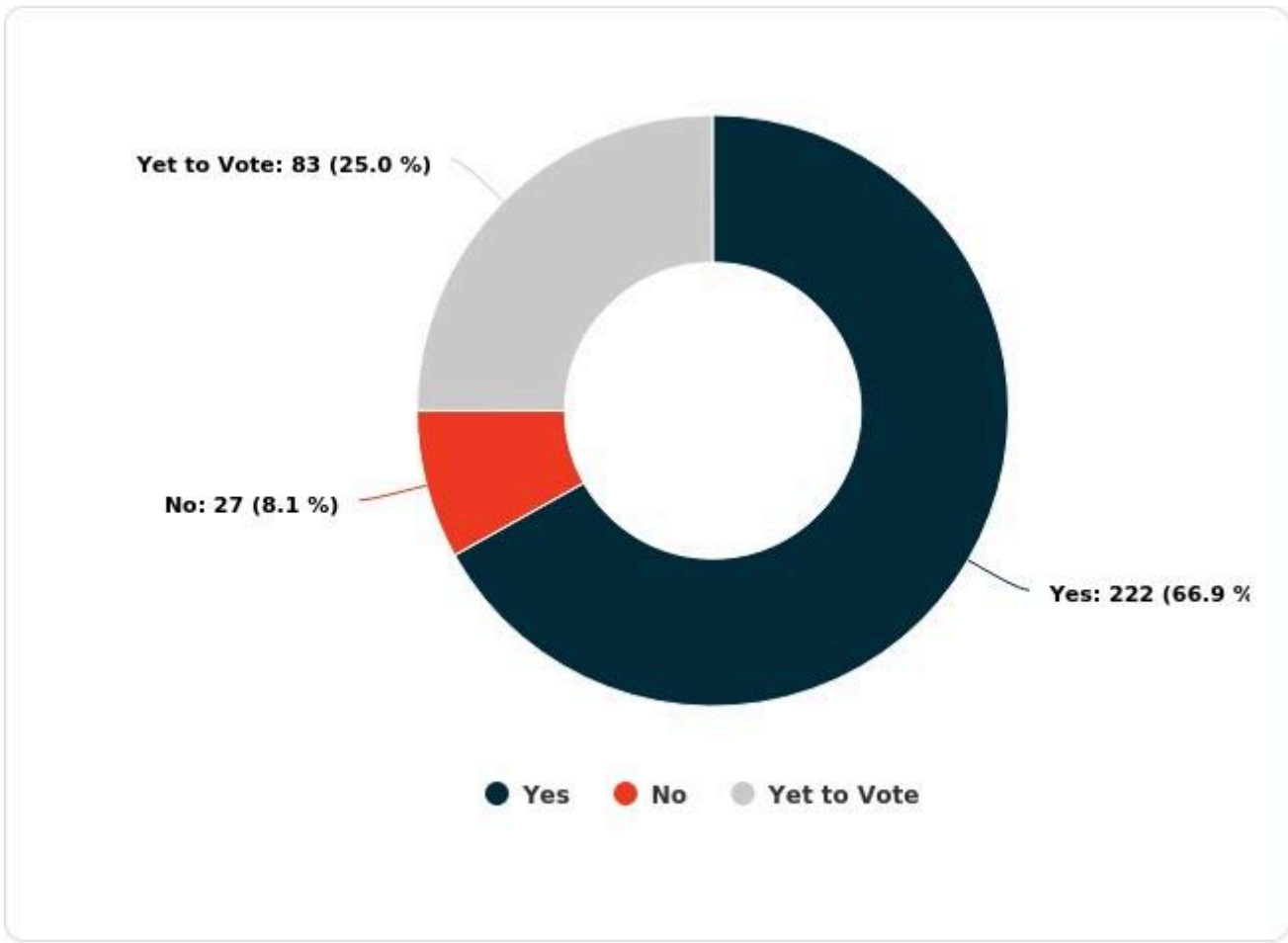
4. An unlimited number of stoppages of work for the duration of 6 hours?



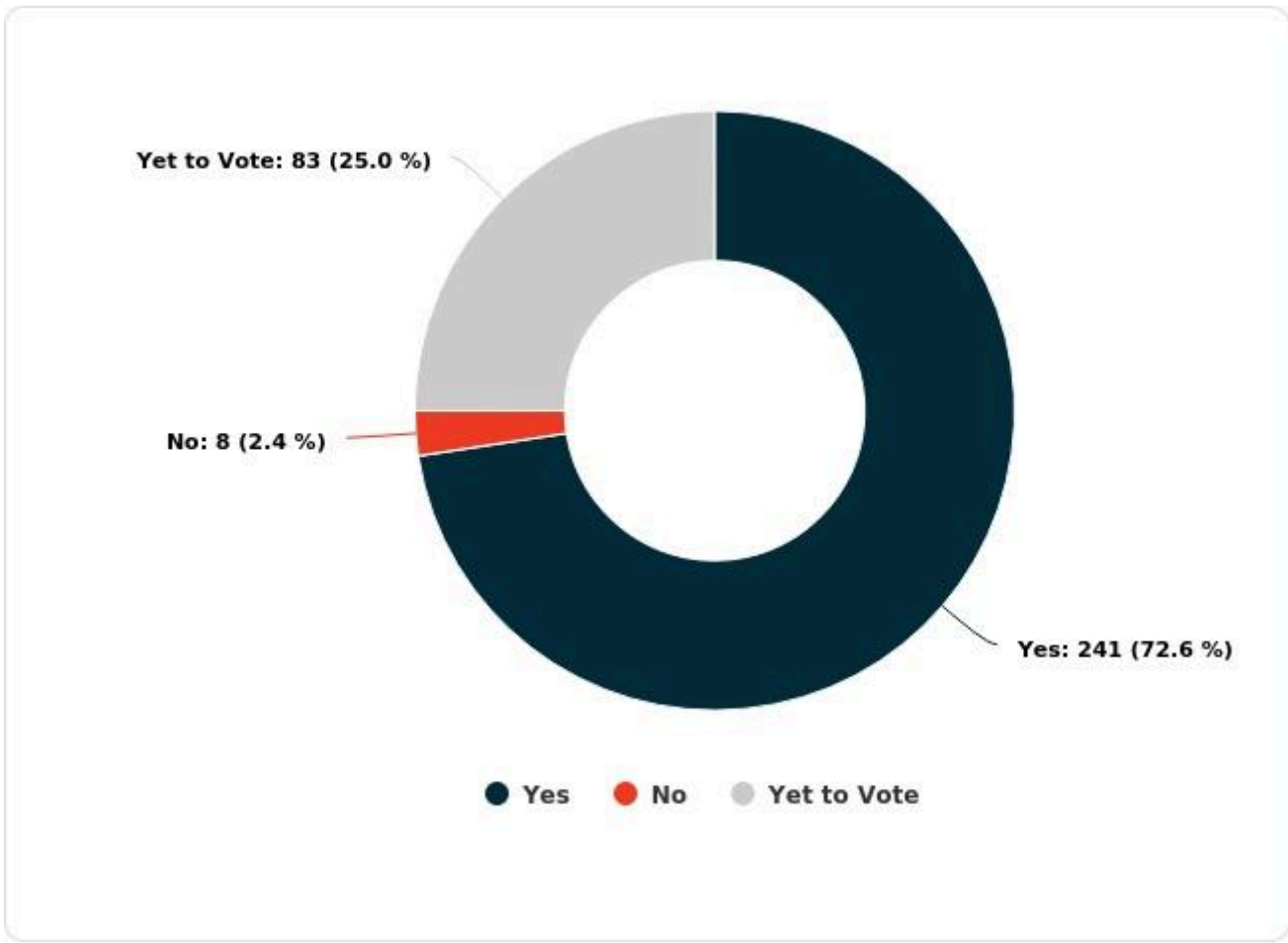
5. An unlimited number of stoppages of work for the duration of 12 hours?



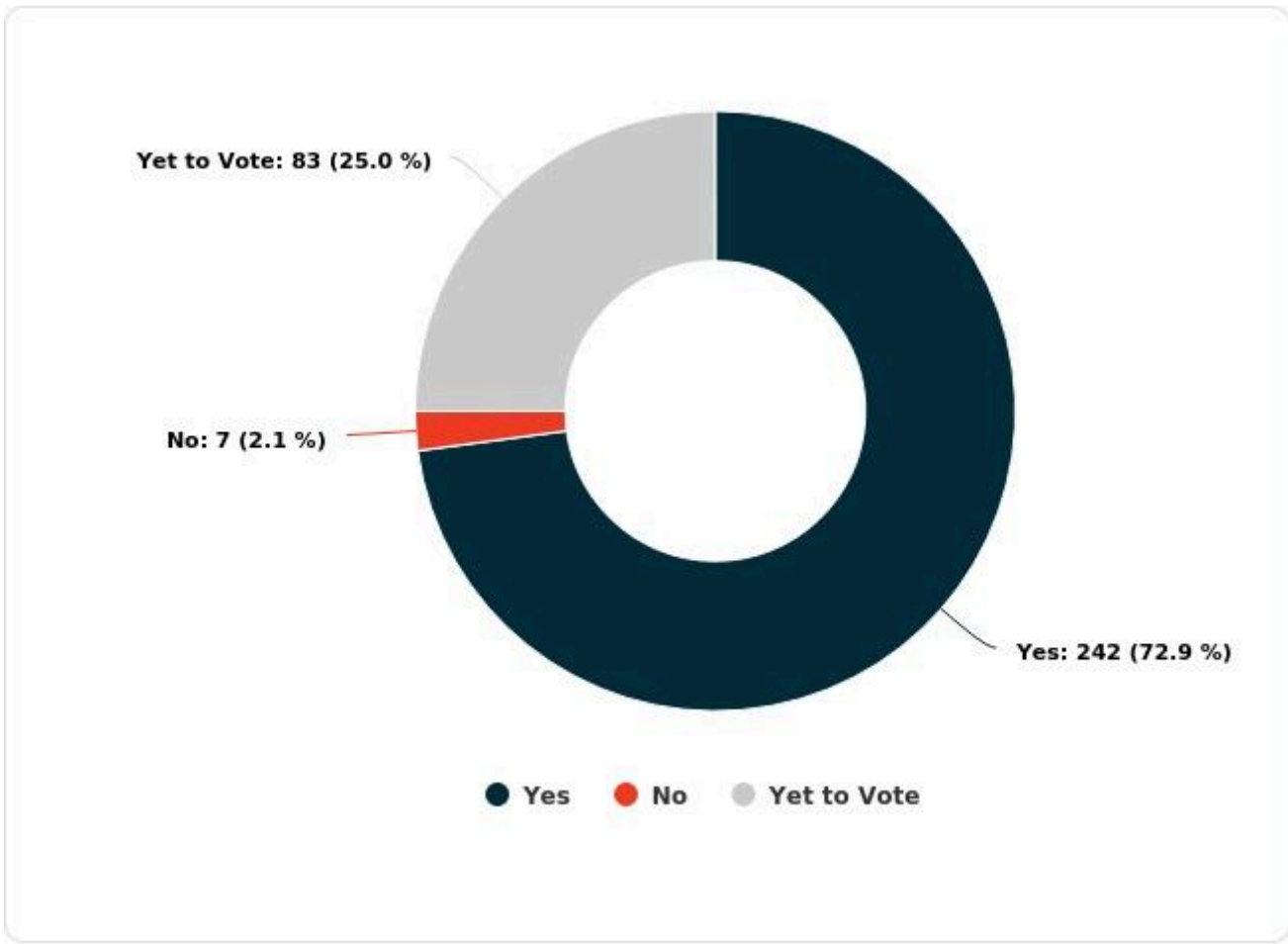
6. An unlimited number of stoppages of work for the duration of 24 hours?



7. The action is to include the late unlocking of prisoners by 30 minutes to allow CPSU members to meet and discuss the bargaining activities prior to unlock?

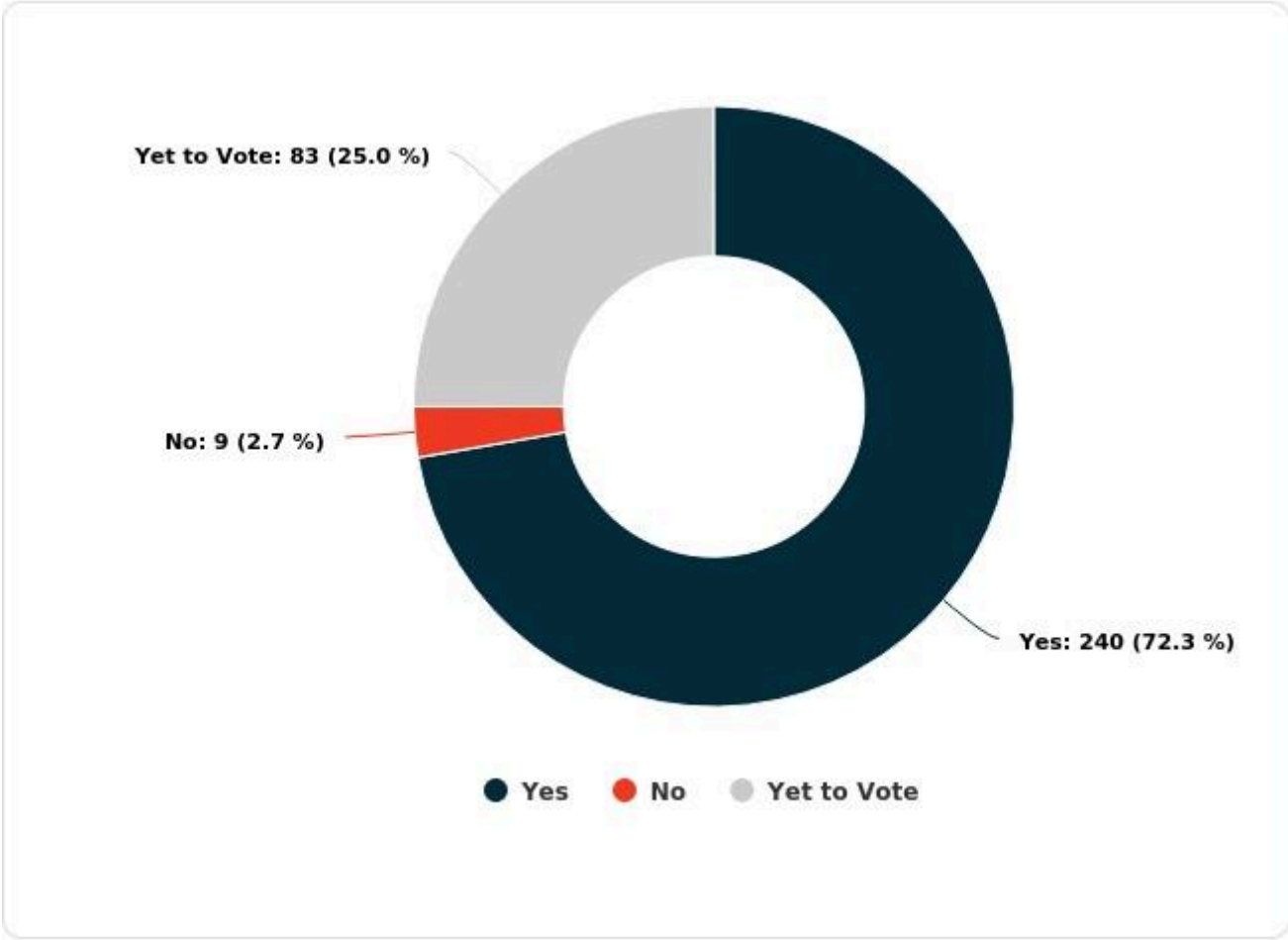


8. The action is to include the early lockdown of prisoners by 30 minutes to allow CPSU members to meet and discuss the days bargaining activities?

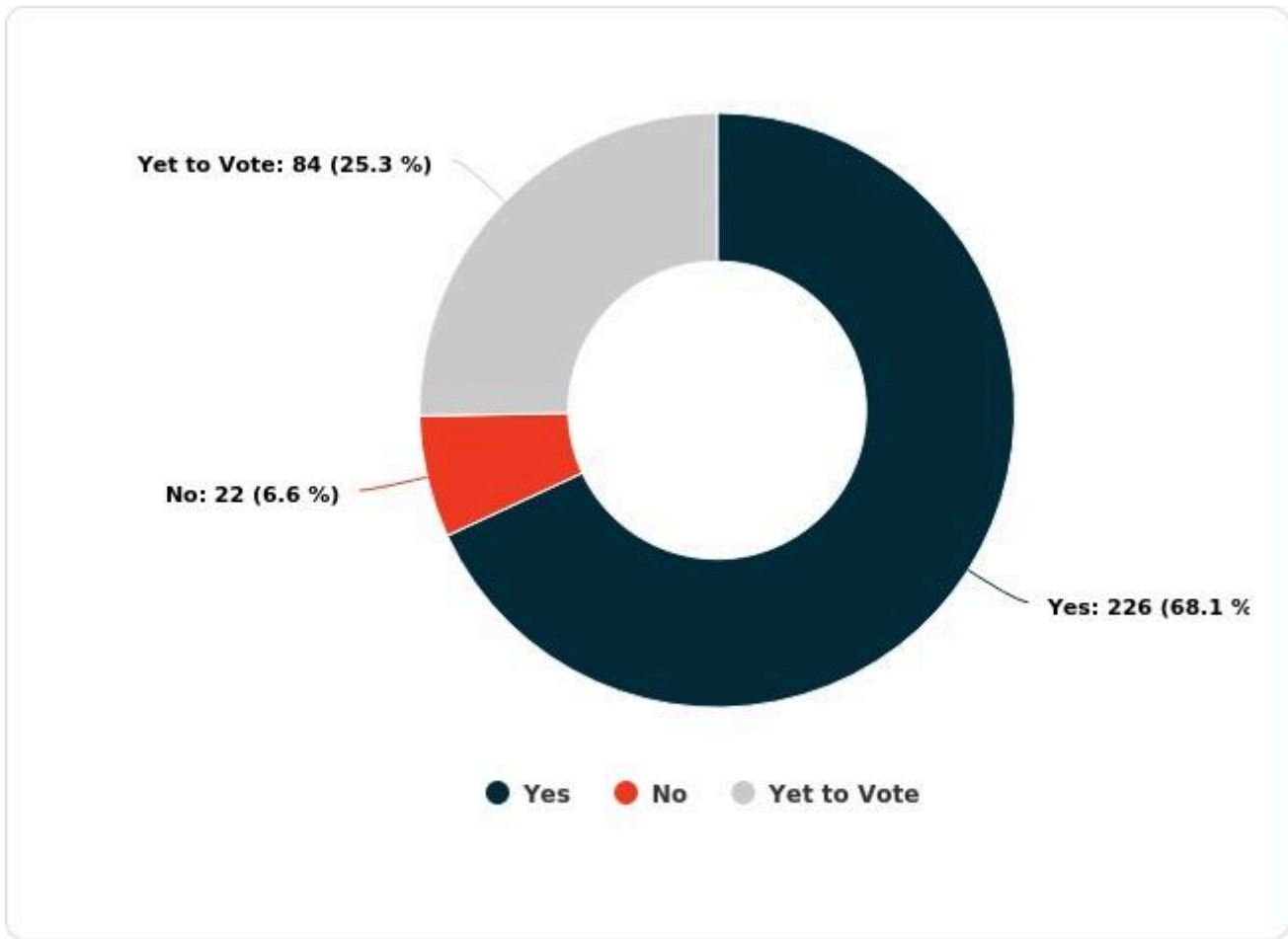

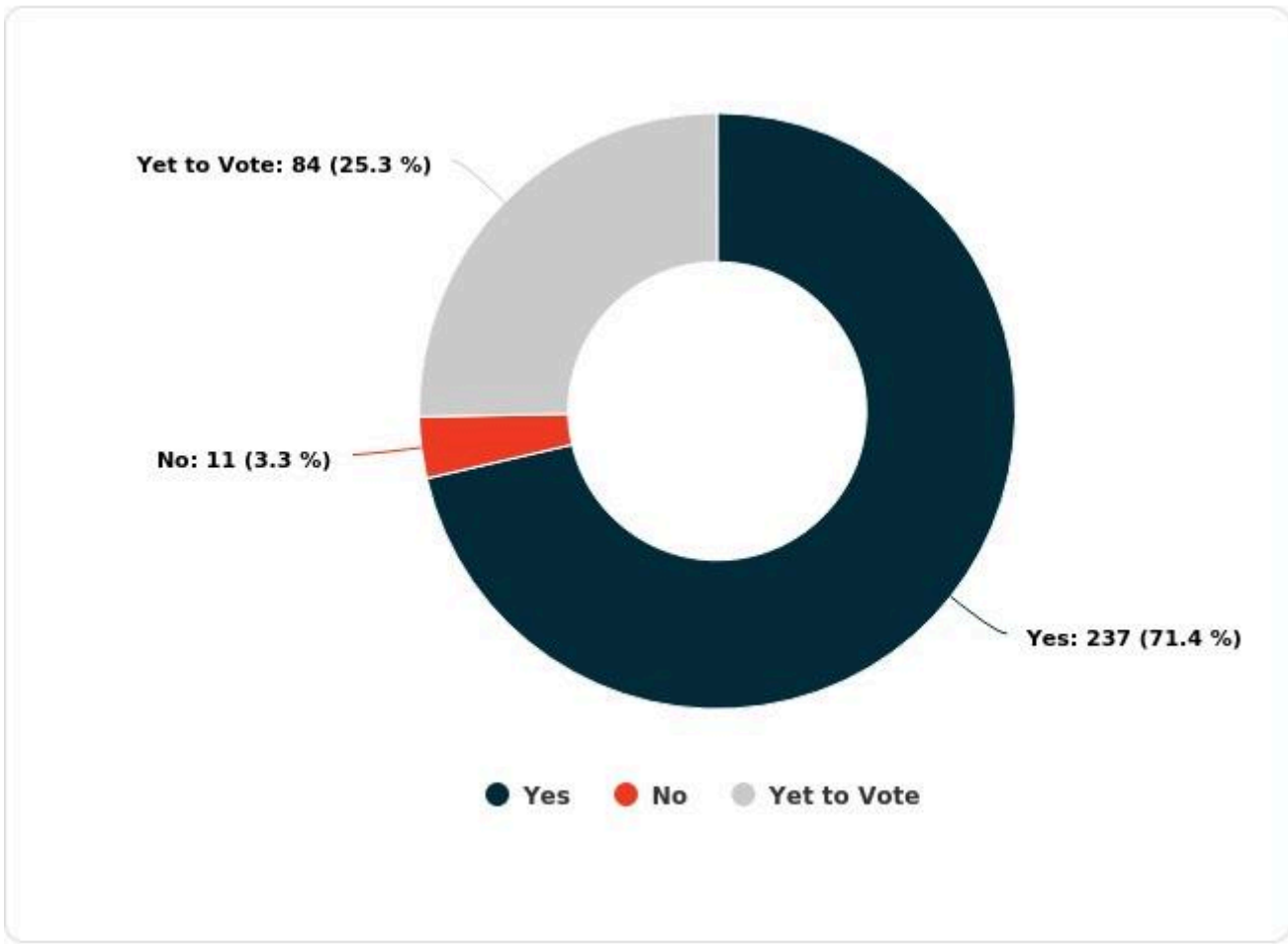

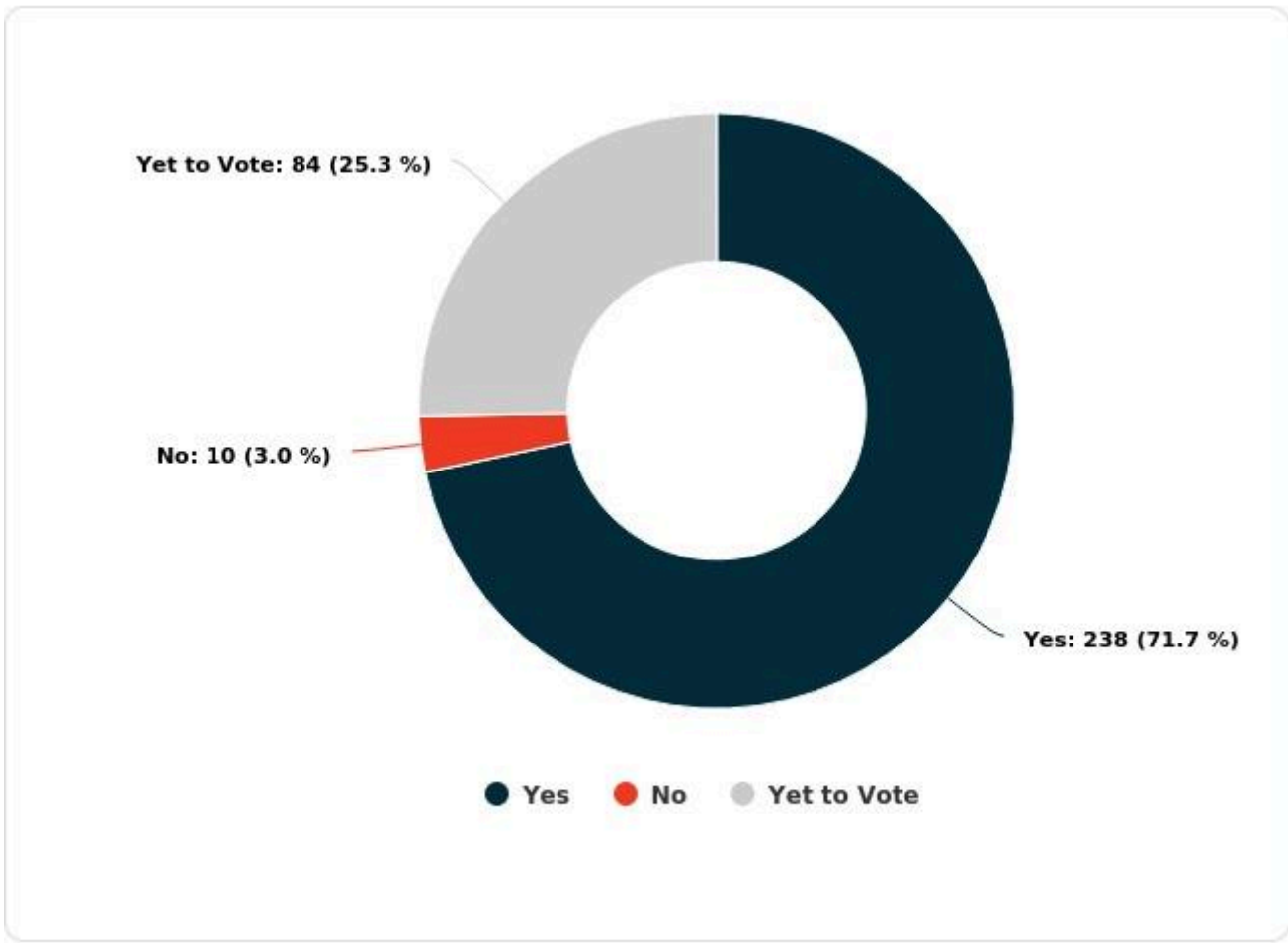
10. Indefinite ban on complying with the media policy of G4S (Port Phillip Prison) allowing members to speak with the media?



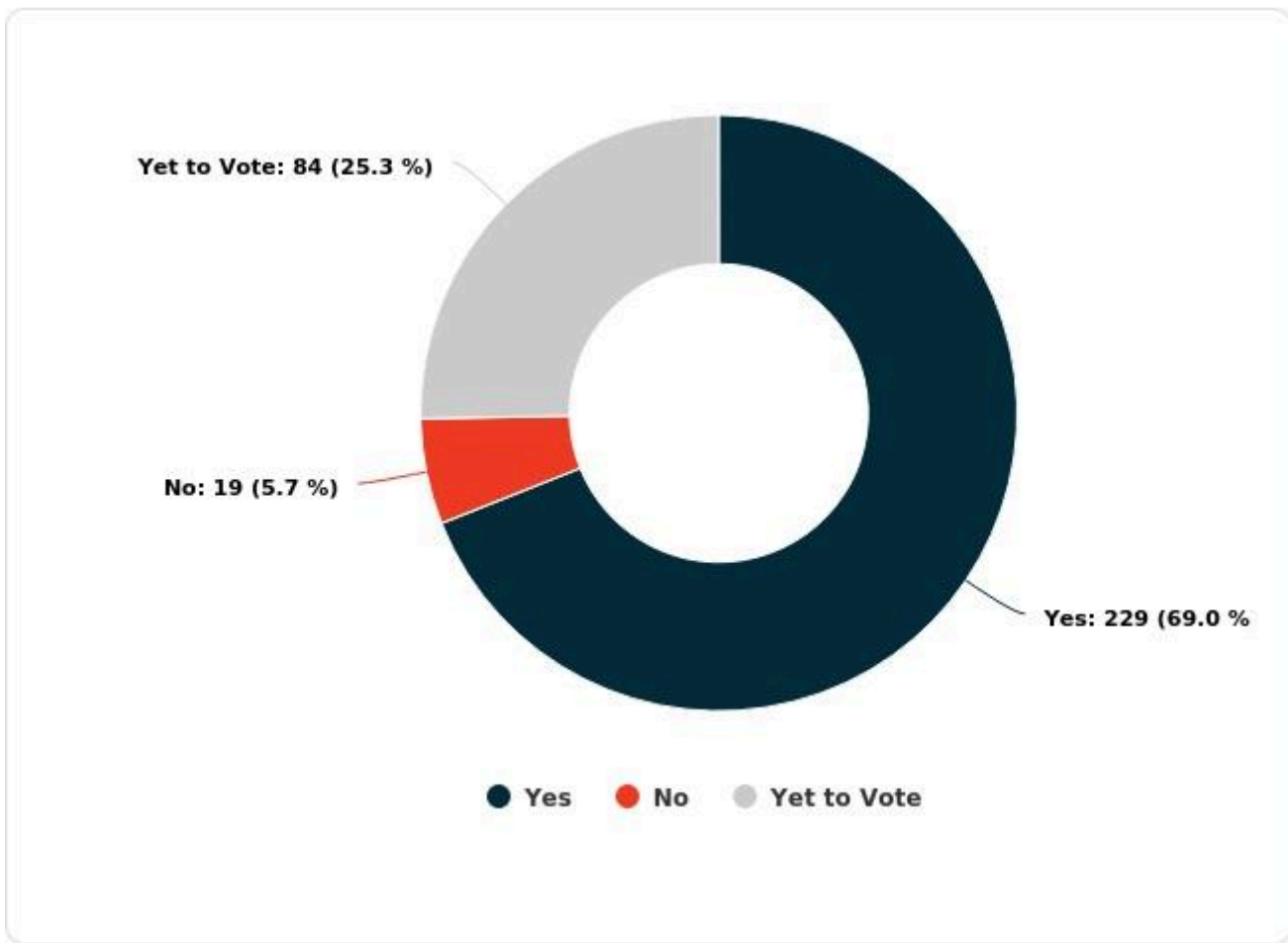
11. Indefinite ban on staff redeployments except for safety reasons?
