Outcome of Registered Organisations Governance and Compliance External Review Final

In late March 2023, the General Manager engaged two external reviewers to undertake an independent review to identify opportunities to improve service delivery for registered organisations. The [terms of reference](#) for the review were published Commission's website.

In August, the General Manager received a [report outlining the findings of the independent review](#).

The reviewers made around 25 recommendations. The Commission has begun work on over half of the report's recommendations. Read about how we are implementing these recommendations, as well as a brief history of the review process, and steps from here, in the [General Manager's response](#).

Updated guidance note on elections

Organisations and branches are sometimes affected by issues that can affect their election timeframes. In recent years, we saw this when the Australian Electoral Commission suspended elections following the outbreak of the COVID-19 pandemic. This resulted in delays to elections and sometimes has had effects on when terms of office started.

In August, we released an [updated guidance note](#) for registered organisations that are dealing with election delays and their ongoing effects, including having their election cycles becoming 'out of sync'.



Getting prepared for financial reporting time

Registered organisations with a 30 June financial year end will be busy with financial reporting. We have a range of resources available on our website to help you comply with the requirements. You can use our [compliance calculator](#) to help you comply with the legislated timeframes.

5% rule fact sheet released

Does your organisation have a rule allowing for a committee of management meeting to be called by 5% or fewer members to consider the audited financial report? This is sometimes known as a '5% rule' and it can streamline the process of presenting the audited financial report to the committee of management if used correctly.

Auditor independence fact sheet

An essential pillar of an auditor's responsibilities is their independence. All Australian auditors are bound by the APES 110 Code of Ethics for Professional Accountants (including Independence Standards) (the Code). We have recently released a [new fact sheet](#) outlining the principles of auditor independence, the requirements of auditors under the Code and threats to auditor independence, to provide clear information about how these issues affect the auditors of registered organisations.
