Re. C2013/6333 - Application by Independent Education Union for an Equal Remuneration Order

I refer to the recent decision by the Full Bench in [2017] FWCFB 2690 concerning whether the Commission should conduct a preliminary hearing as proposed by United Voice and the Australian Education Union. In that decision, the Commission indicated that it was awaiting advice from the IEU as to how we wish to proceed with our application.

The Union has considered the abovementioned decision and the matter more generally and wishes to proceed with its application, independent of any preliminary hearing in Matter No. C2013/5139.

Accordingly, the Union requests that Matter No. C2013/6333 be listed for a directions hearing to enable the parties to timetable the matter, with a view to progressing our application.

Discussions have not occurred with the other parties with respect to a possible agreed timetable. At this stage, the IEU proposes the following filing deadlines for the consideration of the Commission and the other parties.
